
Objectives: - evaluate need for revision

- enhance competitiveness



### Findings of the Evaluator

- improve definitions (e.g. import, seed)
- synchronise DUS testing for PVP and for listing
- make DUS more flexible for conservation varieties
- harmonise VCU criteria
- stronger involve private industry in seed certification
- harmonise seed certification and plant health
- strengthen role of the CPVO
- make Common Catalogue a tool for consumer information (breeding techniques etc.)





### Findings of the Evaluator (II)

- set GMO thresholds for seeds
- replace seed marketing directives by a regulation

#### Ideas of DG SANCO

- check list of species
- re-define VCU
  - focus more on environment/consumer protection
  - offer module system (similar to Danish system)
- Official seed certification
  - reduce to export?
  - stronger involve private industry
- Exemptions:
  - preserve exemptions for landraces/seed mixtures
  - consider concept of small producers/local markets





## Ideas of DG SANCO (II)

- strengthen role of the CPVO
  - synchronise DUS tests for PVP and for listing ("one key, several doors")
  - in charge of variety denominations (central database)
  - in charge of Common Catalogues
  - but: no EU-centralised listing
- harmonise seed certification and plant health
- replace seed marketing directives by a regulation





## Position of EU Sed Industry - Principles

Future EU Legislation on Seeds & Plant Propagating Material

- better harmonised
- quicker, simpler, cheaper
- orientation on needs of the stakeholders
- innovative plant breeding for sustainable & competitive agriculture

# Position of the EU Seed Industry – Improve Definitions

- e.g. "placing on the market":
  - explicitly include direct imports
  - exclude from definition imports for processing and immediate re-export
- e.g. "seeds":
  - treated seeds/plants for planting = seeds
- e.g. "under official supervision"
  - include delegation of official tasks to private entities (e.g. issue of official certificates)





## Position of the EU Seed Industry – DUS

- co-ordinated and audited by CPVO ("one key, several doors")
- envisage reduction of testing sites
- allow for private involvement in DUS testing under official supervision
- no further weakening for conservation varieties etc.





## Position of the EU Seed Industry - VCU

- apply same principles in every MS (harmonisation)
- test only for what is really needed (flexibility)
- allow for private VCU testing under official supervision
- continue to focus on agronomic traits
- yield remains important also for sustainability
- include environmental related aspects as appropriate
- but no environmental or safety risk assessment





# Position of the EU Seed Industry – Common Catalogue

- administered by CPVO
- web-based with online access
- real-time listing of new varieties
- for information only
- including the following information:
  - variety denomination
  - characteristic properties
  - protection status (plant variety protection/patents)?
  - breeding methods only if legally requested





## Position of the EU Seed Industry – Official Seed Certification

- indispensable for agricultural species
- not only for exports, but also for Common Market
- more private involvement under official supervision
  - include pre-basic and basic seeds
  - allow for private seed certification as a service to third parties
  - include all activities: field inspections, sampling, analysis, issue of certificates





# Position of the EU Seed Industry – Quality Standards

- highest possible standards wanted, not the "smallest common denominator"
- Member States shall remain free to set higher legal standards
- include seed industry in the setting of standards
- harmonize with plant health legislation
  - prioritize
  - include stakeholders
  - allow testing under official supervision





## Position of the EU Seed Industry – Exemptions

- conservation varieties, amateur varieties, preservation seed mixtures
  - stricter requirements for evidence of genetic erosion
  - longer grace period
  - clear distinctiveness/variety description
  - call for official testing
  - limit the amounts
- marketing of seeds for production of agricultural raw material to be deleted
- marketing of seeds of plant varieties not yet listed to be maintained
